1 General information

We take the protection of your personal data very seriously. The data protection information applies exclusively within the scope of the General Data Protection Regulation (DSGVO). This data protection notice informs you about the processing of personal data. The data protection information applies to interested parties, customers, suppliers and service providers with regard to personal data that is transmitted to us in particular in connection with business transactions relating to the initiation of deliveries, provision of services, deliveries or the conclusion and execution of contracts or that we collect and process in this context.

2 Person responsible

GREIPL GmbH, Brunnwiesen 38 94481 Grafenau is responsible for the processing of personal data.

3 Personal data of interested parties, customers, suppliers

We process personal data of employees or contact persons of interested parties, customers, suppliers, which we receive from the delivery of products, the provision of services and from or in connection with the initiation, conclusion and execution of contracts.

This includes, in particular, title, name, business contact data (e.g. address, telephone number, mobile number, e-mail address) and other data that is transmitted to us or results from the respective context (e.g. associated business partner, position or function, activity as a permanent or freelance employee, special knowledge or skills, nationality, language, authorization to represent, location of the activity, duration of the activity).

In the case of sole traders, self-employed persons or other individuals, we collect and process personal data associated with the business or entrepreneurial activity, in particular personal tax number, VAT identification number, bank details, information on services provided and their invoicing.

For services that are billed on a time and material basis, working hours (in particular duration, date and time), information on business trips (in particular duration, means of transportation, hotel, travel expenses) and services provided by individuals may also be recorded and processed.

We may supplement existing information from publicly accessible sources, in particular from the business partner's website, commercial registers, address databases and company directories. We also use services to provide business information on the creditworthiness and performance of companies. We do not process any special personal data (Art. 9 DSGVO) in relation to suppliers or their employees, unless this is required by law.

4 Purpose of the processing

We process personal data in connection with the initiation, conclusion and performance of contracts. Processing also includes, in particular, the use of data for contacting and communicating, making appointments, access control and managing access to GREIPL GmbH systems, facilities and buildings, making and receiving declarations and recording and invoicing services.

Furthermore, we store and process personal data insofar as this is necessary to comply with legal regulations, in particular to comply with reporting regulations, import and export regulations, sanctions lists, laws against money laundering, trade restrictions, commercial and tax retention obligations, workplace safety regulations and labor law and collective bargaining regulations (in particular to comply with regulations relating to illegal employment, unauthorized temporary employment and minimum wages).

We also store and process personal data in order to manage, maintain and optimize business relationships efficiently, transparently and in a documented manner. The use of personal data also includes, in particular, use for the following purposes: ensuring the availability of goods and services; ensuring functioning supply chains; checking the reliability, creditworthiness and financial stability of customers and suppliers; providing collateral; evaluating business partners according to economic criteria; compliance with GREIP GmbH specifications, requirements and guidelines, checking and documenting the quality and quantity of services; compliance with product-related requirements and legal obligations (e.g. compliance with product-related requirements and legal obligations (e.g. arising from product safety)); checking and documenting the correctness of invoicing; asserting claims and defending against claims in and out of court; ensuring the integrity and security of our systems (including IT systems), equipment, facilities and buildings; managing business partners' access to IT systems and records on the use of IT systems; bookkeeping and preparing financial statements; carrying out checks and audits; exercising domiciliary rights (including visitor management and access controls); organizing events (trade fairs, events, training courses, etc.); preventing damage to our systems (including IT systems), equipment, facilities and buildings; managing access to IT systems and

records on the use of IT systems. Prevention of harmful behavior and investigation of criminal offenses; statistical evaluation and analysis of business partners with regard to deliveries, services and prices.

5 Legal basis

We process personal data of business partners for the above-mentioned purposes to initiate or fulfill a contract (Art. 6 para. 1 [b] DSGVO), to fulfill legal obligations (Art. 6 para. 1 [c] DSGVO) and in our legitimate interest (Art. 6 para. 1 [f] DSGVO). Our legitimate interest lies in the pursuit of the above-mentioned purposes, in particular in managing, maintaining and optimizing our customer relationship efficiently, transparently and in a documented manner. In other cases, we process personal data of business partners on the basis of consent (Art. 6 para. 1 [a] DSGVO).

6 Disclosure of personal data within GREIPL GmbH and to third parties

We treat personal data of business partners confidentially in accordance with the applicable data protection laws. General and special contractual agreements on the confidentiality of information remain unaffected.

In principle, we only pass on personal data within GREIPL GmbH insofar as this is necessary to fulfill the above-mentioned purposes. Insofar as purchasing, procurement or distribution of goods and services is also carried out by individual divisions of GREIPL GmbH for other divisions, necessary information on these business partners may also be passed on to the respective divisions of the company.

Personal data will only be passed on to third parties if this is necessary and legally permissible for the above-mentioned purposes. Personal data may be passed on to various third parties, in particular in the context of the initiation, conclusion and execution of contracts. These include, in particular, service providers for business information and agencies, logistics service providers, consulting companies (including lawyers, tax consultants, auditors), banks and providers of payment services.

The transfer of personal data to domestic and foreign courts, authorities or other state institutions takes place exclusively within the framework of legal regulations or if there is a legitimate interest in doing so.

7 Duration of processing

We process personal data for as long as necessary for the above-mentioned purposes, i.e. generally for the duration of the business relationship, the complete execution and handling of the contractual relationship and in accordance with the statutory retention obligations, in particular in accordance with commercial and tax law.

8 Data security

We take technical and organizational security measures to protect the personal data we manage against destruction, loss, alteration, unauthorized disclosure or unauthorized access.

Your data is password-protected on all systems in which it is stored. The people who have access to it are prohibited from passing on your data to third parties due to strict security requirements. Our security measures are constantly being improved.

9 Your rights

You have the right of access to your personal data, the right to rectification, erasure, restriction of processing, the right to object to processing and the right to data portability, in each case in accordance with the statutory provisions.

If the processing of personal data is based on your consent, you have the right to withdraw your consent at any time without affecting the lawfulness of processing based on consent before its withdrawal.

You can also contact our data protection officer to assert your aforementioned rights.

You have the right to lodge a complaint with the competent supervisory authority in accordance with the statutory provisions if you are of the opinion that the processing of your personal data violates the statutory provisions.
